General Terms and Conditions

- The dog owner assures that the dog to be cared for is free of contagious diseases and parasites, sufficiently dewormed, and has sufficient vaccination protection. The vaccination certificate must be presented at the latest on the trial day.
- The dog owner expressly assures that there is sufficient liability insurance for the dog to be cared for, including outside care.
- The dog owner assures that his dog is duly registered and chipped in the Swiss dog register (AMICUS).
- The dog owner assures that his dog is not aggressive against people and other dogs.
- The dog owner remains the owner of the animal during the time of care by Happy-Hound-Hotel
- Happy-Hound-Hotel is not liable for any damage to persons or property. For damages caused by the dog during the care to third parties, the dog owner is solely liable.
- For damages that the dog may suffer during the agreed time of care; Happy-Hound-Hotel assumes no liability.
- Happy-Hound-Hotel commits itself to keep the dog species- and behaviorally appropriate and to observe the Animal Welfare Act and its ancillary provisions, as well as not knowingly exposing any dog to danger.
- If Happy-Hound-Hotel considers veterinary treatment is urgently necessary, especially in case of injuries of the dog, the dog owner agrees that the dog will be presented to a veterinarian immediately in the name of and on behalf of the dog owner as well as on his account.
- The dog care includes walking with the dog for at least one hour per day (can vary depending on the condition of the dog and the owners requests) The walks will take place with a leash, and may be together with other dogs that are cared for.

- The dog owner is expressly informed that during the care time a risk may exist such as biting, other injuries and accidents. Happy-Hound - Hotel assumes no liability for this unless pure negligence on our part.
- Happy-Hound-Hotel excludes any liability for damages under civil law.
- In case of incompatibility every dog can also be rejected. This applies to both males and females!
- Any peculiarities / fears of the dog that could put him, the care staff or third parties in danger, must be communicated in advance (chases joggers, cars, cats, bicycles; is afraid of people, etc.)
- The dog owner is obliged to keep the agreed days of care and to inform the dog care service at least 24 hours in advance, if the days cannot be kept or changed.
- For cancellations at short notice, Happy-Hound-Hotel may charge a cancellation fee equal to half of the agreed fee.
- The data provided in the care contract is used exclusively for information about the dog and will be used only for this purpose. A passing on of the data by the dog care does not take place.
- The care contract concluded between the dog owner and the dog care Happy-Hound-Hotel can be terminated by both parties, without giving reasons 7 days before the end of the month
- Happy-Hound-Hotel assures that the dog is cared for in the house and garden and is not accommodated in a kennel. Exception is the night rest from about 22.00 clock to about 06.00 clock, in this time there are generous boxes in the house in which each dog can find peace and is protected.
